ALL that close of pasture lying and being in Chelworth in the said parish of Cricklade St. Sampson commonly called 'Plants', containing by estimation 9 acres, heretofore in the occupation of Thomas Trinder the elder, since of Joseph Trinder and now of William Waine... and also the messuage or tenement, dwelling house, barn, stables and other outhouses in and upon the same premises erected and built ... all which said premises were heretofore part of the lands and inheritance of one David Trinder afterwards of the said Joseph Trinder, and then of William Martin Trinder, Eleanor Trinder and William Green or some of them ... and were bought among other lands ... by the said Francis Saunders ... TO HAVE AND TO HOLD ... for the term of one whole year ... YIELDING AND PAYING therefore ... one whole pepper corn if lawfully demanded ...

Attached to the seal fold of the document is a seal, in red wax, c $2~\mathrm{cms}$ x $1~3/4~\mathrm{cms}$., bearing the small central impression of a male bust, somewhat worn.
