they present and say that Thomas Hayes who lately held of this manor two messuages or tenements formerly converted into one but now into three and late in the occupation of John Cripps but now of the said John Cripps, James Ashdown and Gilbert Ashdown formerly erected and were built by the said John Cripps on a small piece... of land containing about a quarter of an acre by him purchased of Stephen Larkin being part of the premises the said Stephen Larkin held of this manor and by the said John Cripps conveyed to the said Thomas Hayes by fealty and suit of court from three weeks to three weeks and rendering for a heriot at the death of every tenant the best live beast, if any, if none then three shillings and four pence for a dead heriot and a year's rent for a relief upon every death or alienation and by the yearly rent of 14d died seized thereof since last court whereupon relief became due to the Lord and a hog was seized for a heriot. And that the said Thomas Hayes by his will devized the said premises to Elizabeth Hayes his widow. And the said Elizabeth Hayes being present in court paid the relief and quitrents craved leave to compound with the Lord for the heriot and was admitted tenant but her fealty is respited.
