Court held by John Fferrers esquire Lord of the Manor there held the sixteenth day of November 13 Elizabeth...to this court came Richard Hatton the attorney of William Rowlowe and Frances his wife to testify to Thomas Garbott and William Gubbold, two customary tenants there, that he had surrendered into the hands of the Lord one toft and half a virgate of land of his together with the appurtenances in Dalycott to the use and behoof of his son Richard Rowlowe...his heirs and assigns in perpetuity...and to the above court came the said Richard in his own person and was admitted to the said toft and half a virgate of land...by the steward of the said manor...and he gave as a fine 5s. 4d. and pledged fealty and was admitted... dated the day and year above stated under the seal of Edward Moseley gentleman steward for the time being there.

Indenture made 1st January 26 Charles II (1674) between Ellener Rowly, late wife of Daniel Rowly late of Wyken in the parish of Worfeild in the county of Shropshire, one of the customary or copyhold tenants of the manor of Wyken of the one part and Thomas Sheppard of Wyken yeoman of the other part...whereas Thomas Talbott of Worfeild esquire, lord of the aforesaid manor of Wyken, by his deed dated the last day before the day of the date hereof, hath given and granted unto the said Ellener Rowly full and free liberty, license, power and authority to grant and demise and to farm let unto the aforesaid Thomas Sheppard...for the term of twenty-one years if the said Ellener shall so long live...all her customary messuage...and also all or any part of her yard or half yard of customary land and one meadow called "Broad Dale", one meadow called "The Meadow" being reputed to be part of the said yard and a half... situated within the manor of Wyken in the tenure or occupation of the said Daniel Rowly previously, but now in the possession of the said Thomas Sheppard...now this indenture witnesses that the said Ellener for and in consideration of the yearly rent and seven covenants &c. hereafter concluded...hath granted and demised set and unto farm let...unto the said Thomas Sheppard ...all the above mentioned messuage and lands... to have and to hold for and during the term of twenty-one years... yielding and paying therefore unto the said Ellener Rowly the sum of thirty pounds per annum...

First I do bequeath my soul into the hands of Almighty God &c...and as for what worldly estate it hath pleased God...to bestow upon me...I do dispose of as followeth...

As for my personal estate within doors and without, both quick and dead, after my funeral charges are discharged, and all my debts paid, I do give and bequeath unto my wife, my son <u>John</u> being my second son and my daughter Elizabeth to be equally divided betwixt them.

I do constitute and appoint my loving uncle Thomas Bach of Vighgrand, now in the parish of Clauly, within the county of Shropshire, yeoman to be sole guardian of my children until each of them do attain unto the full age of one and twenty years (or anyone who my said uncle Thomas Bach shall appoint be guardian in his place and stead).

And lastly I do constitute and appoint my loving brother in law Thomas
Gressney of the parish of Codsall in the county of Staffordshire yeoman to be my sole executor to this my last Will and Testament...

In witness thereof I have hereunto put my hand and seal the twelfth day of December 1696.

I gave unto my son William Bache my great Bible. I give untoomy sons John, Thomas and Samuel Bache the sum of twenty pounds to be equally divided amongst them. I give unto my son in law John Cauldwall my spitts boots and my clock after my wife's decease. I give unto my son in law John Bell forty shillings. I give unto my son in law Moses Whitehouse forty shillings. I give unto my son in law John Cauldwall forty shillings. I give unto the executors of my son in law Jonathan Brooke forty shillings for the use of my granchildren Brookes. I give unto my son in law Simeon Ashe forty shillings. I give unto my son in law William Ffoxall forty shillings. I give unto my two grandchildren Ffoxall five pounds to each of them. I give unto all the rest of my grandchildren twelve pence a piece. I give and leave unto my wife all the rest of my household goods and personal estate to be at her disposal. I do constitute and ordain my son William Bache to be my sole executor to perform this my last Will and Testament revoking all former wills &c.. Dated 11th August 1712.

MANOR OF WYKEN: COURT BARON OF SHARINGTON DAVENPORT ESQUIRE LORD OF THE MANOR HELD THERE ON THE 23RD DAY OF FEBRUARY 11 ANNE - THE COURT OF THOMAS RICHARDS GENTLEMAN STEWARD OF THE MANOR, THOMAS BILLINGSLEY, ROBERT BARRETT, JOHN SADLER SENIOR AND JOHN SADLER JUNIOR JURATES THERE PRESENT.

To this court came Thomas Bach of High Gravenor one of the customary tenants of this manor in his own person and surrendered into the hands of the Lord by the steward a toft called "Barretts Yard", one messuage now in the tenure or occupation of Michael Billingsley, one close of land adjoining and half a close of certain customary land in Pillingshall with the appurtenances situated within the manor and which said parcels of land contain by estimation one nooke of land to the use of William Bach his son and heir apparent...and in the same way to this court came William Bach in his own person and was admitted tenant to the lands...to have and for the term of his life on payment of the fine of five shillings...

To all christian people to whom these presents shall come I Henry Warter of Crooke Meale in the county of Shropshire gentleman send greeting... whereas by his surrender dated 9th March 1723 William Bach and Martha his wife at a court baron of Henry Davenport esquire, late Lord of the Manor of Wyken, in the county aforesaid, two of the customary tenants of the same manor did surrender into the hands of the Lord...one toft called "Barretts Yard", one messuage and close adjoining containing half one nooke of land, two messuages, one yardland, one nooke and half one nooke of land, four cottages, two fisheries in Chirl, one meadow called "Bridge End Meadow" otherwise Mill Parock, one meadow called "The Paddock" and three acres of arable land with their appurtenances situate in the village of Wyken in the manor aforesaid...to the use and behoof of the said William Bach and Martha his wife for their lives...and after their several deceases to the use and behoof of the heirs of their body...subject to a proviso that in case the said Martha should happen to die without issue... that it should be lawful for her by any deed to appoint a payment of any sum of money to any person...not exceeding the sum of four hundred pounds...and whereas the aforesaid Martha Bach did publish and declare her last Will and Testament dated the 7th June 1736 and did thereby bequeath several lagacies for certain persons therein named to the value of four hundred pounds and did therein nominate and appoint me the said Henry Warter sole executor thereof ... and I the said Henry Warter have proved the said will in due form of law...now know ye that I the said Henry Warter have the day of the date hereof received the sum of one hundred pounds of William Bach...in part of the said four hundred pounds...
