Tempus Edward III (incomplete)

A grant from ----- daughter of Richard Tyrenache of Christ's Church of Twyneham to Andrew Elys and Matilda his wife of land in Christ's Church, near land of William Arnewode.....

The witnesses are: William Galon, John Tirenache, Roger, Longe, Geoffrey Kyppelyng and William de Warham.

2.

Tempus Edward III

A grant from John Couere of Christ's Church of Twyneham to Andrew Elys and Matilda his wife of a yearly rent of 1d arising out of a tenement in Christ's Church of Tynham, near Andrew's tenement and that of William de London, which yearly rent John Beel used to pay to John Couere.

The same witnesses as in No. 1.

1331.

Grant by Joan, at one time daughter of Richard Tyrenache, in her widowhood, to Andrew Elys and Matilda his wife, of tenements which Joan had by the gift and grant of Edith, formerly the wife of Henry Clement, in the town of Christ's Church of Twynham.

The witnesses are: William de Buthestorn, William Gundevely, John de Farnhulle, William de Warham, John Tyrenache, Roger le Lung and William de Purbyke.

Dated at the feast of St George 4 Edward III.

4.

1331.

Grant by Andrew Elys to Richard le Hauker and Margery his wife of land lying in 'La Portfold' of the town of Christ's Church of Twynham, as also land near 'la Bostele', and land near 'Worgelhulle' and land near 'Euere'.

The witnesses are: Richard Farnhulle, Roger le Olde, Roger le Lange, Geoffrey Kypling and Henry Gilberd.

Dated at Christ's Church of Twynham Monday next after the feast of the Nativity of St John the Baptist 4 Edward III.

5.

1339.

Grant from Andrew Elys to John Swyft and Margery his wife, daughter of Andrew Elys, of a property in the town of Christ's Church of Twynham, which property he had by a charter of infeofment from the said John Swyft...

The witnesses are: Richard de Farnhulle, William le Lange, Richard le Blake, Roger de Buteschorn, Robert le Lange, Roger le Olde and William Rogeres.

Dated at Christ's Church of Twynham, Thursday in the feast of St George the Martyre 12 Edward III.

6.

1349.

Grant from Margery, the daughter of Andrew Elys to Walter Doyst, of a tenement in Christ's Church of Twynham, near the tenement of John le Blake and Joh Jelus in the town field...

The witnesses are: Roger le Longe, William le Longe, Thomas Patrick, William Rogeres and Henry Smedenor.

Dated at Christ's Church of Twynham on Sunday next after the feast of St Lucy, 22 Edward III.

7.

1354.

Grant from John le Carpenter, called Skymour, to William Cole and Alice his wife of a place (placca) in the town of Christ's Church of Twynham, without 'la Barres' near the land of Philip Candele and John Swyft, extending from the high road leading to Wymbourne to the road leading to the bridge of Eovere...

The witnesses are: William Rogeres, William de Kent, John le Olde, William Beaumont, Walter Wa-----, John le Blake and John Gibbes.

Dated at Christ's Church of Twynham, Tuesday next after the feast of St Mathew the Apostle and Evangelist 27 Edward III.

8.

1441.

Acquittance by Roger Ivey Esquire and Anastacia his wife, late the wife of William Warner of Poole, to Stephen Houchon otherwise called Stephen Warner executor of the will of the said William Warner, of all actions either personal or otherwise...

Dated 18th September 19 Henry VI.

9.

1439.

The will of William Warner of Poole, county Dorset, dated 1st March 1438, in which 6/8 is left to the fabric of the church of Salisbury, 1/- to each priest for masses. A tenement in Poole and brewhouse to Anastacia his wife; a tenement in Poole, which he had by the gift of Alice Houchon, late wife of Alexander Shakespear, to William Byshippe; a tenement in Poole called Tavorne to Anastacia; 6/8 to the parish of Poole; lands in Poole and Wymborne Mynstre to Richard Byle and Stephen Houchon.

Proved at Caneford 27th November 1439.

10.

1448.

Will of Walter Gyle dated 30th January 1448, willing his body to be buried in the cemetery of St James the Apostle of Poole; to the church of Salisbury 4d; 8d to the same for oblations; 2d each for each altar in Poole church; 8d for the cross in that church; a tenement in Poole near the tenement now of William Boyes once of Robert Bomell and near to the land of John Spardarde is left to Thomas Coke, who is appointed executor of the will.

Proved 20th January 1449.

Lease from Robert Kempston and John Neuborgh to Thomas Northovers and agnes his wife of a tenement in the town of Christ's Church, near the tenements of John Colgill, late William Tanner and John Colgill late of Robert Glover for 40 years.

Dated at Christchurch 8th October 28 Henry VI.

1501.

Lease dated 4th January 16 Henry VII by Richard Havelond to John Bedford of a capital tenement and garden in Poole, near the lands of John Neubye and Nevill Mesurer for the term of his life at a rent of 53/4 yearly.

13.

1503.

Indenture between Henry Bruges of Newbury, county Berkshire, gentleman and John Doget, tailor, of London of the one part and John Bedford of Poole,

merchant, Thomas Betford of Newbury, clothier and Thomas Devenysshe of Spynhamlonde, county Berks of the other part.. witnesseth that hwere those of the other part by their writing obligatory of this date are bound to Bruges and Diget in £100, the said writing is made to the use of Robert, one of the sons of Nicholas Betford deceased for his share of his father's goods and thereupon Henry Bruges and John Doget granted by these presents that if the above said three persons of the other part pay unto Robert Betford when he is 21 years of age the said £100, then the writing shall be void. If Robert should die before he is of age then those of the other part shall pay the £100 to Margery Bruges mother of the said Robert.

Dated 22nd November 18 Henry VIII.

1513

Grant from Henry Chattock and Alice his wife to William Davy and Christina his wife and John and Catherine their children, of property in Christ Church Twynham near land of John Colgyll, of land in Portfylde, for their lives at a yearly rent of 7/-.

Helyas Imberley was appointed attorney of Henry and Alice.

Dated 20th February 4 Henry VIII.

15.

1514.

Grant from John Jarden, son of Robert Jarden of Pole in the county of Dorset to John Bedford of Pole of a tenement in the West Street of the town of Pole near the lands of the priory of Bradynstoke and the lands of the said John Jarden and of Nicholas his brother, and of John Carpenter. Thomas Whight and William Mesurer appointed attornies of John Jarden to deliver seisin. The witnesses are : John Stockar, Peter Dicar, Richard Havelond, burgesses, Thomas Collys, bailiff of the town of Pole.

Dated 9th May 5 Henry VIII.

16.

1515.

Lease dated 4th March 6 Henry VIII from James Cole gentleman to John Bedford the elder of Pole of a tenement in Longham and land in Hythe for a term of 12 years at a rent of 40/-.

17.

1521.

Grant by John Plommer of Pole , miller and Alice his wife to Richard Havelond of Pole, of a tenement etc in Pole, near the property of John Fysemann, which tenement etc are the inheritance of Alice, since her fathet's death.

The witnesses are: John Havalond, Mayor of Pole, John Bedord, Thomas Wyght, William Mesurer, John Stoccar, Burgesses of Poole and Richard Alen, brewer, then bailiff there.

Dated at Poole 15th September 12 Henry VIII.

18.

1526.

Grant from Thomas Westbury to Thomas Hancock, Richard Genge and John Bevyle of property in the parish of Christ's Church Twynham, in a place called 'Est Mersche', near the meadow of the prior there called 'Ilysham'.

Dated 10th July 17 Henry VIII. Sealed in the presence of Thomas Holdyne and James Trymer.
